SERVICE AGREEMENT

The following agreement will remain valid for future service, with the exception of any agreed upon changes in fees or frequency in the total number of visits. *Geist Pet Sitting* accepts telephone reservations or emails for service and may enter your premises without additional signed contracts or written authorization. The parties hereto agree to the following fees:

One Pet: \$13.00 - \$18.00 per visit (20-30 minutes) Based on mileage & frequency of visits
Additional Pets: \$1.00 - \$3.00 each (PICK-UP & DROP-OFF KEY \$5.00 EACH TRIP)

Holidays: There will be a \$5 fee in addition to the regular per visit fee for services on New Years Day, Easter, Memorial Day, 4th of July, Labor Day, Thanksgiving, Christmas Eve, Christmas Day and New Years Eve.

VETERINARIAN AUTHORIZATION: During my various absences, *Geist Pet Sitting* will be caring for my animal(s). I have contracted for services from *Geist Pet Sitting* during my absence and I authorize *Geist Pet Sitting* to act on my behalf to request veterinary treatment and services when they deem it necessary. I accept full responsibility for charges incurred in the treatment of my pet(s).

- A. All visits requested or necessary shall be paid for at the agreed rate. Any additional necessary costs such as food and supplies shall be paid for by the client.
- B. In the event of personal emergency or illness of regular pet sitter, client authorizes *Geist Pet Sitting* to arrange for another qualified person to fulfill responsibilities as set forth in this contract. **Client will be notified in such a case. For this reason, we do request two keys from the client.**
- C. *Geist Pet Sitting* agrees to provide the services stated in this contract in a reliable and trustworthy manner. In consideration of these services and as an express condition thereof, the client expressly waives and relinquishes any and all claims against *Geist Pet Sitting* unless arising from negligence.
- D. *Geist Pet Sitting* shall not be held responsible for the loss, injury, death of any pet(s) that the client has let outside or has instructed the sitter to allow outside. **For instance, a dog might choose to break the installed electric fence while outside.**
- E. The client fully understands the contents of this contract and by signing below takes full responsibility for prompt payment (check or cash). **Client agrees to leave full payment in the home, to be picked up at the first visit of that petsitting.** Daily dog walk clients pay each Monday for that week's service. Please make check payable to *Geist Pet Sitting*. A LATE charge of \$10.00 may be added if a payment is not received within 10 days of completion of service.
